

The University of Nevada, Las Vegas invites applications for the following **temporary, part-time, hourly** position located in the University Libraries.

Information Literacy Fellow, UNLV University Libraries

Role of the POSITION

This position is a temporary, part-time Information Literacy Fellow who will work to improve the accessibility of existing digital instructional content and develop new GIS (geographic information systems) digital learning objects (DLOs). In this work, the Fellow will assist librarians in maintaining and identifying necessary updates to existing material, and support the creation of new DLOs.

The successful candidate will be paid \$20 per hour. The anticipated schedule is 12 to 19 hours per week based on the availability of the incumbent, to be completed by mid-May, and not to exceed 300 total hours for the fiscal year. There are no benefits associated with this position.

Training will be provided to ensure success in the duties described above. Training may include:

- UNLV Office of Accessibility Resources Foundations of Accessibility (or similar)
- Time to learn the technology selected for the projects

Responsibilities

In collaboration with the Teaching and Learning Librarian in the Educational Initiatives and Scholarly Communication and Data Services departments, the person in the position will learn recommended instructional design practices for creating digital educational content. They will apply this knowledge to improving the accessibility of existing content and developing new, GIS-related content to aid those working in commonly used software to visualize spatial data. It is expected that four new digital learning objects will be created during the course of the fellowship.

MINIMUM QUALIFICATIONS

We are seeking a **UNLV graduate student or advanced undergraduate student** who has a strong interest in instructional design and interest in GIS and/or data visualization. Experience using GIS, or other data visualization tools is not required for this position - training will be provided as needed. Instructional design experience is not required for this position —training will be provided as needed.

- Experience in using common functions in video editing software (e.g., cutting and splicing video, syncing audio and video tracks, screen capturing)
- Interest in instructional design and accessibility in higher education
- Interest in GIS and/or data visualization
- Independently learns and navigates complex systems while experimenting with tools to make informed recommendations.
- Maintains strong attention to detail in repetitive tasks and consistently meets deadlines.
- Exhibits effective collaboration and communication skills.
- Practices good organization skills
- Proficient in the use of the Google Suite of products such as Google Documents, Google Sheets, Gmail, Google Calendars, etc.
- Proficient in the use of Microsoft Office products such as MS Word and Excel

PREFERRED QUALIFICATIONS

- Familiarity with the general concepts of accessibility for audio and video files
- Experience working in a library environment
- Experience creating or editing transcripts or captions for multimedia files
- Experience with GIS or other data visualization tools
