Executive Summary

The Florida racino industry includes slot machines at seven pari-mutuel locations: Calder Casino & Race Course, Flagler Dog Track and Magic City Casino, Gulfstream Park, Big Easy Casino, Casino Miami Jai Alai, Harrah's Pompano Beach Casino (previously known as The Isle Casino), Hialeah Park, Pompano Park, and The Casino at Dania Beach (previously known as Dania Jai Alai). This report collects total statewide data for all locations going back to January 2010 and includes data on the number of units, total play, net revenues, and hold percentage, as well as market share.

Note: Big Easy Casino* was closed between September 2017 to May 2018 due to water damage from Hurricane Irma.

*Previously known as Mardi Gras Casino.

Definitions

Units: Average number of devices reported in operation

Credits In: Dollar amount of money played on all machines at the location

Promo: Dollar amount of promotional credits played at the location

Net Revenue: Dollar amount of money retained by slot machines after paying jackpots

Y/Y Δ: Percentage change from previous year's net revenue

WSD: Average win per device per day for the month in question

Hold%: Net revenue as a percentage of total credits in

Promo %: Promotional credits as a share of net revenues

MS: Total market share, calculated as the percentage of total racino revenue brought in by the location in question
