Summary

This report is the best known (by us at least) publicly-available source for all U.S. commercial casino revenue on a monthly basis. It gathers together monthly data from every available jurisdiction. It uses publicly-released data from state regulatory bodies. The terminology varies; but next to each state you will find the total casino (or racino) win reported for that month, whether it is called revenue, win, adjusted gross proceeds, or any other variant. We have also included video poker win for Louisiana and Illinois. Sports betting and fantasy revenue, where available, is also included in our reported win. The “%Δ” column indicates year over year change for that jurisdiction.
